Your 2019 Summer Award (if any) will be based on your eligibility and attendance for the 2018-2019 Academic Year. You must complete a 2018-2019 Free Application for Federal Student Aid (FAFSA).

**ALL STUDENTS MUST REGISTER** for summer classes prior to submitting this form. We will determine your summer eligibility for financial assistance based on your registered, program eligible, credits. **We will not determine an award unless you are registered for summer classes.** If you change the number of credit hours you are enrolled in, please contact our office as your eligibility may change.

- **Pell:** If you were awarded the Federal Pell Grant for the 2018-2019 Academic Year, you **may** have Federal Pell Grant funds remaining to use for the Summer Semester.
- **Loans:** Eligibility for student loans will be determined by the Financial Aid Office. If you have not received the maximum loan amounts for your annual loan limits during the 2018-19 Award Year, then you may be eligible for a summer student loan. Students can only be awarded loans up to the annual loan limits allowed. Students must be registered for at least 6 credits to be loan eligible.
